ENROLLMENT CONTRACT

I wish _____ to be enrolled in _____ at Cedar Hill Prep School for the 2016 - 2017 academic year.

Enclosed is my check for \$600.00 to reserve a place in the school for the student. This is non-refundable. **This amount will be deducted from the 1st month's tuition due on June 30, 2016.**

I understand that my obligation to pay the required fees for the full academic year (10 months) is unconditional and that after April 30, 2016 no portion of such fees paid or outstanding will be refunded or cancelled in the event of absence, withdrawal or dismissal from the school of the above student.

I understand that in signing this Enrollment Contract for the coming academic year, I am agreeing to accept the rules and regulations of the School as stated in the current handbook. I understand that the student's violation of the rules and regulations of the School could constitute sufficient cause for dismissal. **I understand that if my account is 60 days or more delinquent, Cedar Hill Prep School, at its option, may advise me that my child will not be permitted to attend classes or will be dismissed from the School and that the School may withhold transcripts and diplomas until the end account is placed on a current basis.** All fees are due when rendered as indicated on the School's scheduled invoices and will be so paid.

I agree that the student named above may participate in all school activities, including athletics, and any required school sponsored day trips away from the campus. This permission may be modified, in writing, by mutual agreement.

This Enrollment Contract contains the entire agreement between the parties. All prior agreements or understandings, representations, or portions thereof, whether written or oral, are hereby abrogated and superseded in their entirety by his Enrollment Contract and its terms and conditions. This Enrollment Contract shall be construed in accordance with the laws of the State of New Jersey, with venue of any arbitration or litigation to be in Somerset County, New Jersey. Should any provisions be stricken, the remaining provisions shall remain in full force and effect. This Enrollment Contract may only be modified in writing by mutual agreement of the parties. The School reserves the right not to issue an Enrollment Contract for subsequent years. Current enrollment does not guarantee a right to future enrollment.

To ensure a place for my child, both this signed contract and my deposit must be returned to the Business Office by April 15, 2016. This contract shall become binding after being signed by the parent(s) or guardian(s), and upon acceptance by the School.
